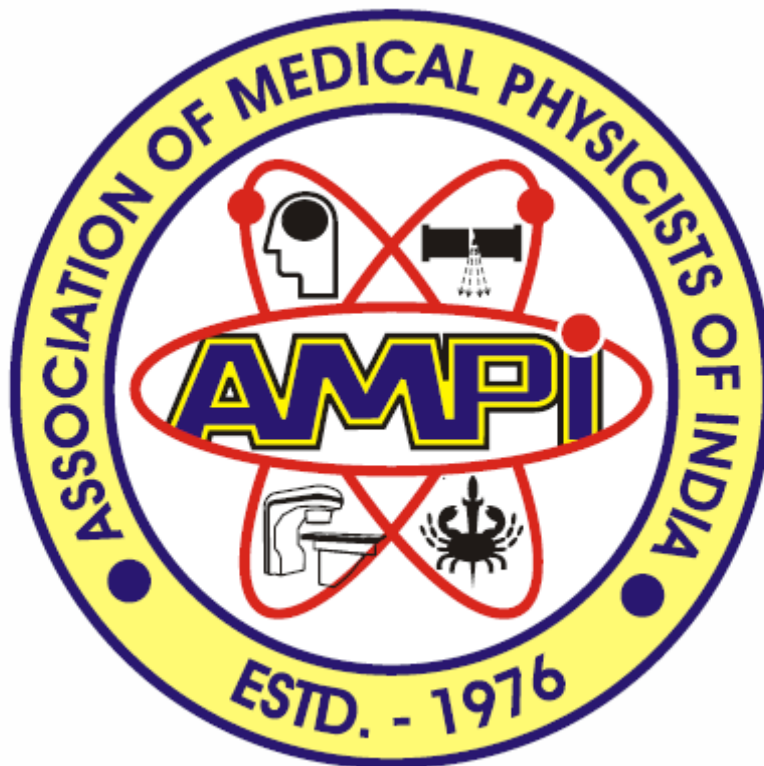

## ASSOCIATION OF MEDICAL PHYSICISTS OF INDIA (AMPI)

The Association of Medical Physicists of India was founded in 1976 with the objective of encouraging the application of physics in medicine. It provides a forum for medical physicists in the form of annual conferences/ workshops/ symposia/ seminars (at national and international levels) and publication of a quarterly journal (Journal of Medical Physics, JMP) for the exchange of ideas and dissemination of knowledge and experience in the field of Medical Physics. The Association collaborates with similar organizations in the world to raise the quality of medical physics in India. Currently, it has more than 1400 active members comprising of radiation/ medical physicists, radiation oncologists, radiologists, engineers and technologists. The wide spectrum of membership reflects the multi-disciplinary nature of the medical physics and the association. In 2008, AMPI constituted its autonomous scientific and educational wing, the College of Medical Physics of India (CMPI), to initiate the evaluation and certification programme for the qualified medical physicists. The college has also been entrusted to formulate the policy of accreditation of education and training centres in the country. Now, the association has four wings namely, the Executive Committee, the Board of Trustees, the College and the Journal. AMPI is affiliated to International Organization for Medical Physics (IOMP) and is constituent member of IOMP regional chapter, the Asia-Oceania Federation of Organizations for Medical Physics (AFOMP).

## ANNUAL REPORT OF EXECUTIVE COMMITTEE FOR THE YEAR 2012-2013

### [A] Highlights of Executive Committee Meetings/ Decisions/ Actions Taken

Since the last Annual General Body meeting held on September, 2012, Executive Committee (EC) met three times to transact the business of the Association. Following are the important decisions/ actions taken by Executive Committee during this period:

1. **AMPI website development & Elections (2013-15):** AMPI-EC has discussed about the Electronic Electoral process for AMPI Elections for the year 2013-15. In this regard, every member expressed that the existing AMPI website ([www.ampi.org.in](http://www.ampi.org.in)) need to be actively upgraded with meaningful web design. It has been decided to change the vendor of existing AMPI website to M/s Network Systems, Vellore. EC has decided to have dynamic website which should incorporate the data base of all enrolled members & to interact all through group mail facility.
2. **AMPI to join as associative member in International Cancer Congress –ICC- 2013:** President informed members that there was invitation to AMPI from Organizers of ICC-2013 to be held in Delhi from 23-25 November, 2013. Vice president Mr. Munjal attended the ICC committee meeting and apprised AMPI EC members of the details of the role of AMPI in the forthcoming ICC-2013, which are as follows:
  - a. AMPI logo has been included in the website of ICC -2013
  - b. No travel grant for the invitees, however local hospitality will be provided by the organizers.
  - c. The details of scientific program related to medical physics have not yet been finalized.President – AMPI informed the members that few international faculties who have outstanding research contribution in various advanced state of the art topics can be invited. The members have approved the list of names proposed by the president.
3. **Enrolment of AMPI Members:** 90 new life members were enrolled during the 2012-13 financial year and their databases have been uploaded at AMPI website. As on 31<sup>st</sup> July 2012 there are 2120 life members on the role of the Association including 90 life members enrolled during this year.
4. **AMPI – IPEM Collaboration:** President Dr.D.D Deshpande was invited by IPEM to attend the Annual meeting of IPEM held in London in Sep 2012.
  - President informed the members that a MOU was made and according to which, IPEM President /representative can be invited for the annual meeting of AMPI to strengthen the relationship/collaboration of the two societies.
  - IPEM has suggested that AMPI may nominate its members who have research contribution to be part of their Special Investigation Groups, SIG's (like Task groups) as Corresponding Members in various topics. It will give good idea how these SIG's work. The following members have been recommended by the EC to be part of the IPEM SIG's .

### 5. **AMPI Travel Grant**

The following deadlines were set and approved by the EC to receive the application for AMPI travel grant for various quarters.

6. **To initiate the Electronic Electoral process for AMPI Elections for the year 2013-15:** It was proposed to conduct e-elections. Some members have expressed displeasure that our website is not equipped to conduct e-voting. Secretary has informed that he has bank of 1800 e-mail ID's of the members and confident enough to conduct e-elections. Later on it was confirmed by the members that the Election Officer will take a decision on this matter. For the Election officer to conduct coming elections (2013-15) of AMPI EC & Trust through e-mode, Dr. Manoj Semwal's was proposed by EC.
7. **ICMP – 50<sup>th</sup> year of Medical Physics:** On occasion of completeing 50 years of IOMP, International Conference of Medical Physics, Brihgtton, UK has requested AMPI to nominate Indian medical physicists whose contribution to Medical Physics is outstanding in the field of research, education, societal activities etc. in the last 50 years. They will put up posters of 50 selected Medical Physicists during the conference. The following persons have been identified which was approved the EC. The members are as follows: Dr. S. J. Supe, Dr P. S. Iyer, Dr U. Madhavnath, Dr A. S. Pradhan, Dr. A. V. Lakshmanan, and Dr. P. S. Negi.
8. **Constitution amendment:** President has informed that amended constitution will be submitted to Charity Commissioner for its approval shortly. If the constitution amendments are authenticated by the charity commissioner, before July 31<sup>st</sup> 2013, then according to the new amendments the term for the new AMPI EC will be three years, otherwise it will be for two years as per the old norms.

## [B] Scientific Activities

### *AMPICON 2012*

33<sup>rd</sup> (AMPICON-2012) Annual Conference of the Association of Medical Physicists of India (AMPI) was organized during November 1-3, 2012 organized by Kasturba Medical College, Mangalore in association with KMC, Manipal & Karnataka Chapter AMPI at Dr. TMA Pai International convention center, MG Road, Mangalore – 1. The theme of the conference was " *Frontiers in Medical Physics - Innovations and Challenges.*".

The scientific programme encompassed a broad range of topics such as image guided radiotherapy, intensity modulated radiotherapy, precision radiotherapy (SRS/SRT/SBRT), New algorithms for treatment planning calculations, Computational methods, Physical and clinical aspects of beam and brachytherapy, Innovations in radiotherapy, Emerging methods of radiation dosimetry, Radiological standards, Quality assurance in radiotherapy, and Further advancements in technology of therapeutic and diagnostic equipments. The invited speakers included many nationally and internationally known experts in the field of radiation oncology, diagnostic radiology, nuclear medicine and radiation protection who are actively engaged in clinical service, teaching and research. Two hundred sixty five papers including AMPI Dr. Ramaiah Naidu Memorial Oration, 17 invited papers, 57 oral, 167 poster papers were presented during the conference. The abstracts of all the papers were published in the conference Proceedings. Dr. R Ravichandran, Chief Medical Physicist, Royal Hospital, Muscat, Sultanate of Oman delivered the 21<sup>st</sup> AMPI Dr. Ramaiah Naidu Memorial Oration (RNMO). The title of his deliberation was "Science of Medical Physics, an impression - Innovations and implementations".

## [C] Journal of Medical Physics (JMP)

Journal of Medical Physics is published regularly and distributed to members who are on the mailing list of the journal. The editorial Board of JMP has also been updated and new experts from India and Abroad have been included. The journal is indexed at a number of scientific indexing agencies including PubMed, PubMed Central and Wikipedia. The current projected impact factor of the journal is 0.4. Electronic submission, Author traceable facility, fast refereeing, fast decision, timely publication and timely mailing have made JMP a very popular journal internationally. Now JMP has a large pool of reviewers from all over the world and publishes manuscripts of very high scientific quality. The JMP is a self sustaining journal financially and even provides funds for other activities of the association.
